

# **Approved Minutes of the Board of Directors Meeting**

#### Webex

February 8, 2024, 1:30 p.m. to 3:24 p.m. Central

#### 1. Call to Order and Determination of Quorum

MRO Board of Directors Chair, Dr. Dana Born, called the meeting of the MRO Board of Directors to order at 1:30 p.m. Central. Julie Peterson, Vice President General Counsel and Corporate Secretary, advised the chair that a quorum of the board was present. A complete list of attendees is included as Exhibit A.

#### 2. Standards of Conduct and Antitrust Guidelines

Pursuant to Policy and Procedure 4, Peterson highlighted MRO's Standards of Conduct and Antitrust Guidelines.

#### 3. Consent Agenda

The consent agenda included draft minutes from the board meeting held on December 14, 2023.

Upon a motion duly made and seconded, the board unanimously approved the consent agenda.

### 4. President's Report

Sara Patrick, President and Chief Executive Officer, congratulated Chair Born and Vice Chair Brummond on their new roles on the board. She welcomed new board members – Fred Meyer from Algonquin Power representing the Generator Power Marketer Sector, Michael Desselle from Southwest Power Pool representing the Transmission System Operator Sector, Sandra Johnson from Xcel Energy representing the Investor-Owned Utility Sector, and Paul Crist from Lincoln Electric System representing the Municipal Utility Sector. She also welcomed guest speaker Joe Marshall, Researcher at Talos, Cisco's Cyber Intelligence Unit, who would be providing a presentation on an innovative solution developed for the Ukrainian utility, Ukrenergo. She noted that Marshall's presentation is an excellent example of public/private partnerships in action to provide innovative solutions to new and emerging risks.

Patrick focused her remarks on the three focus areas MRO had identified for 2024 that support MRO's 2022-2024 Strategic Plan priorities of people, processes, and partnerships. Notable efforts under *partnerships* include MRO's 2024 Regional Risk Assessment (RRA), which had been published earlier in the week, and outreach efforts including engagement with state and federal regulators as well as policy makers. Among MRO's goals focused on *processes*, Patrick highlighted the congressionally mandated Interregional Transfer Capability Study (ITCS) and the associated transition to Energy Planning. She reflected tasks undertaken towards MRO's last focus area, *people*, such as a compensation study performed to ensure that MRO's pay practices and philosophy align with the level



of experience and expertise required by the work, the expansion of 360 reviews to all managers and directors, and an office space management strategy.

#### 5. Chair's Remarks

Chair Born welcomed board members and attendees and thanked Joe Marshall for his presentation to the board. She highlighted the testimony provided by FBI Director Chrisopher Way before the House Select Committee, where he warned of the threat China poses to the energy industry. She noted the evolving risk landscape in the electricity industry, and how partnerships, processes, and people must be leveraged to address these risks. She further suggested a commitment to innovation and continued improvement would be key strategic objectives for MRO as it undertakes its strategic planning later in 2024.

#### The board recessed for a short break.

#### 6. Ukrenergo & Mitigating GPS Signal Interference in Electric Systems

Joe Marshall, Researcher at Talos, Cisco's Cyber Intelligence Unit, presented on his involvement with Ukrenergo, the state-owned electricity transmission system operator in Ukraine and the sole operator of the country's high-voltage transmission lines. He provided an overview of the unique challenges faced by Ukrenergo in maintaining power in an active war zone due to Electronic Warfare (EW), as it pertains to the practice of GPS blocking.

Marshall explained that EW created disruptions in transmission grid operations, as global navigation satellite system (GNSS) time (or GPS time sync) is necessary to calculate Phasor Measurement Units, which are vital to power grid operations. He explained that he and a team of experts collaborated to create a solution – the IE5K – which provided an alternative time clock to GNSS and could easily be inserted into already existing systems. Marshall concluded that his efforts are far from over, as new challenges, such as GPS spoofing, require new and innovative solutions.

In response to questions, Marshall noted that there is no current commercial solution to these concerns, especially as facilities vary in their equipment and configurations.

#### 7. Written Reports

Vice Chair Brummond referred board members to the written reports on operational activities, external affairs, and outreach.

In response to questions, Burt stated that all regional entities have a product like MRO's Regional Risk Assessment, and that MRO's risk ranking methodology had been adopted by the ERO and was consistent. There were no further questions.

# 8. Other Business and Adjourn

Vice Chair Brummond highlighted the upcoming meeting dates. Having no further business to discuss, the meeting was adjourned at 3:24 p.m.
