### **MRO Board Guiding Principles**

### **Standards of Conduct Reminder:**

Standards of Conduct prohibit MRO staff, committee, subcommittee, and task force members from sharing non-public transmission sensitive information with anyone who is either an affiliate merchant or could be a conduit of information to an affiliate merchant.

#### **Antitrust Reminder:**

Participants in Midwest Reliability Organization meeting activities must refrain from the following when acting in their capacity as participants in Midwest Reliability Organization activities (i.e., meetings, conference calls, and informal discussions):

- Discussions involving pricing information; and
- Discussions of a participants marketing strategies; and
- Discussions regarding how customers and geographical areas are to be divided among competitors; and
- Discussions concerning the exclusion of competitors from markets; and
- Discussions concerning boycotting or group refusals to deal with competitors, vendors, or suppliers.

### MRO Operational Activities Report Richard Burt, Senior Vice President and Chief Operating Officer

### Report

To kick off 2024, leadership of the MRO operational departments has been focused on developing goals for the year that support MRO's strategic plan, as well as efforts to mitigate risk for the highest risks to reliability and security across the region as identified in the 2024 MRO Regional Risk Assessment (RRA), slated for release in early February. MRO is hosting a webinar for industry on the 2024 RRA on February 28 from 9am-10am Central.

Reliability Assessments will be a top priority for MRO in 2024 regarding both the Interregional Transfer Capability Study (ITCS) and continued efforts to transition the ERO and industry to energy, rather than capacity, analysis. Both efforts had considerable momentum built in 2023, while having key deliverables due in 2024. These two projects are also key issues that policymakers are interested in and will be a primary input into MRO's state and provincial outreach efforts.

2024 will mark the first year that MRO is fully transitioned into Align for conducting all Compliance Monitoring and Enforcement Program (CMEP) activities and staff is underway implementing new procedures to support that transition for both MRO CMEP staff and registered entities. A second major focus for CMEP in 2024 will be noncompliance processing – looking for ways to more efficiently process noncompliances, allowing for faster turnaround times and a more manageable long-term inventory.

In addition to the primary objectives above, other reliability and security projects being planned for 2024 include the following:

- Conduct outreach and training for industry focused on the highest risks prioritized in MRO's 2024 RRA.
- Staff participation in NERC Standard Drafting Teams that are writing new Reliability Standards related to energy assurance.
- Supporting ERO efforts related to recommendations from the Winter Storm Elliot Inquiry, including
  an analysis of Blackstart capability in the Eastern Interconnection and robust compliance monitoring
  of new Reliability Standards focused on generator performance during extreme weather conditions.
- Implementing new software to allow MRO to perform transfer analyses and energy-based assessments.
- Complete analysis to determine registration changes needed to support the FERC-approved Inverter Based Resource (IBR) workplan, which includes having mandatory Standards apply to smaller generation facilities than has historically been the case, and evaluate the impacts of those changes on MRO's CMEP implementation into the future.
- Maturing the MRO Security Advisory Council Threat Forum (SACTF) to focus on mitigation of emergent security threats in addition to timely sharing of threat information.

### Webinars, Conferences, and Industry Engagement

On January 17, 2024, Sara Smith, Enforcement Attorney, attended "Meet the Assistant Commissioner of Regulatory Affairs (MN Dept of Commerce) and Update from the Commission's Executive Security (Minnesota Public Utilities Commission)" sponsored by the Minnesota State Bar Association. MRO staff are planning for a year full of participation in industry webinars, conferences, and attending in-person and virtual industry engagements.

#### State and Provincial Outreach

On February 7, 2024, the North American Electric Reliability Corporation (NERC) hosted "Beyond Borders: Update on NERC's Interregional Transfer Capability Study (ITCS)." This informational webinar targeted state and provincial policymakers that are interested in learning more about the ITCS. The Electric Reliability Organization (ERO) State and Provincial Collaboration Group coordinated sending invitations for this webinar to state and provincial regulators.

On February 7, 2024, Bryan Clark, Director, Reliability Analysis, Mark Tiemeier, Principal Technical Advisor, and I joined staff from NERC, ReliabilityFirst, and SERC Reliability Corporation, for an introduction meeting with the Chair of the Illinois Commerce Commission, Doug Scott. Topics discussed included the work the Electric Reliability Organization (ERO) Enterprise is doing on interregional transmission and related reliability topics. Chair Scott is Illinois Governor Pritzker's representative on the Midwestern Governors Association's Mid-Grid Initiative, which is currently planning education sessions around regional transmission and planning.

Regarding provincial outreach, MRO continues to send communications to provincial regulators about MRO and ERO Enterprise initiatives and is planning in person engagements with regulators in both Manitoba and Saskatchewan to discuss topics such as the 2024 Regional Risk Assessment and other reliability and security topics.

MRO will continue to communicate MRO and ERO reports and outreach opportunities to commissioners and commission staff, including webinars related to NERC's Long Term Reliability Assessment, the ITCS project, MRO's Regional Winter Assessment, and the 2024 Regional Risk Assessment. MRO continues to coordinate with the ERO Enterprise State and Provincial Outreach Collaboration Group on outreach opportunities in states within multiple regional footprints. Updates will continue to be provided in quarterly board reports.


- 1. Overall, how would you rate this event?

- 5. For virtual attendees, how would you rate your experience with attending this event virtually?




A department goal in 2024 is to continue to expand and mature the metrics used to track MRO's outreach performance.


### **MRO Outreach Dashboard**


### 2022 vs 2023



























# **2023 Outreach Highlights**

- A single survey was created to gather consistent feedback from all events (conferences, training, webinars) and develop benchmark ratings.
  - Efforts to improve survey response rate resulted in 9% increase in participation in 2023.
- Survey findings are:
  - Reduction in total attendees is consistent with reduction in number of events.
  - In-person attendees are up and virtual attendees are down, indicative of pandemic recovery.
  - Total response rate to event surveys increased 9% in 2023 over 2022, possibly suppressing average event score.
- Increased social media engagement attracted 1,467 (+32%) followers in 2023.
