

## Approved Minutes of the Annual Member and Board of Directors Meeting

## Hybrid: MRO Office, St Paul, MN & Webex

December 1, 2022, 10:40 a.m. to 2:52 p.m. Central

Notice for this meeting was electronically posted to the MRO website <u>here</u> on January 8, 2021. A final agenda, including advanced reading materials, was posted on Boardvantage on November 17, 2022.

#### 1. Call to Order and Determination of Quorum

Chair Brad Cox called the meeting of the MRO Board of Directors to order at 10:40 a.m. Central. Julie Peterson, Interim Vice President General Counsel and Corporate Secretary, advised the chair that a quorum of the board was present. A complete list of attendees is included as <u>Exhibit A</u>.

#### 2. Standards of Conduct and Antitrust Guidelines

Pursuant to Policy and Procedure 4, Peterson highlighted MRO's Standards of Conduct, Conflict of Interest, and Antitrust Guidelines.

#### 3. Consent Agenda

The consent agenda included draft minutes from the board meeting held on September 22, 2022, as well as revisions to policies and procedures and board committee charters.

Upon a motion duly made and seconded, the board unanimously approved the consent agenda.

## 4. Chair's Remarks

Chair Cox welcomed board members and attendees, and thanked staff for their continued support of the hybrid meeting format. Cox highlighted MRO's year in review, noting a strong year amidst ongoing challenges.

He further shared remarks regarding incorporating incentives into our standards and compliance monitoring and enforcement program mechanism suggesting that incentives are better than penalties at promoting high levels of reliability and security. He emphasized that he has questions, not answers regarding this concept, but urged that the work to explore these questions is well suited to the ERO Enterprise and its many stakeholders.

Cox reviewed the notable milestones in the evolution of the electric power industry during his career – from providing basic electrification to operating a large regional grid framework efficiently, reliably, and securely. He commended the industry for the planning, design, and maintenance providing benefit to consumers, and expressed interest in the transitions ahead for the future of the industry.

## 5. The Geopolitics of Energy Transition

The MRO Board of Directors welcomed Professor Meghan O'Sullivan, the Jeane Kirkpatrick Professor of the Practice of International Affairs and Director of Geopolitics of Energy Project at the Harvard University Kennedy School of Government. O'Sullivan shared a presentation focused on the global

energy transition to net zero and how it is shaping geopolitics and conversely how the geopolitical landscape is shaping the transition and the pace and scope of how it unfolds.

Board members engaged O'Sullivan regarding harnessing global cooperation in a world based on global competition, what to expect geopolitically post-transition, the role of critical minerals and mineral rights as a transition of the future, and the role of onshoring or "friendshoring" as increasingly common strategic policy approach. O'Sullivan cautioned of an enormous gap between the current challenges and the current trajectory and emphasized the need for serious honest discussions in boardrooms.

## The Board recessed for a lunch break from 12:04 p.m. to 12:47 p.m.

## 6. President's Report

Sara Patrick, President and Chief Executive Officer, welcomed Jim Robb, President and CEO of NERC and thanked him for his mentorship and leadership. She also welcomed keynote speaker, Professor Meghan O'Sullivan, as well as incoming board members for 2023 – John Rhea and Maurice Moss – who were in attendance.

Patrick reflected on 2022 by recalling challenges, celebrating accomplishments, and acknowledging the work that remains. Notable challenges included geopolitical tensions in Ukraine, new strains of malware, and risks to the reliability of the bulk power system, including extreme weather conditions, generator retirements, and increased power demand. She commended expert system planners and operators for maintaining reliability through the summer heat of 2022, and highlighted the MRO's Generator Winterization Program as a key opportunity to help entities prepare for the winter season.

Among MRO's accomplishments, Patrick highlighted seasonal assessments, the Regional Risk Assessment, the risk matrix, the annual risk meeting, and stakeholder outreach. Patrick acknowledged the COVID-19 pandemic as an ongoing challenge in 2022, but celebrated MRO's return to the office and its return to hosting onsite meetings as a considerable accomplishment.

## Recognition of Outgoing Board Members

Patrick next thanked outgoing board members – Aaron Bloom, Michael Desselle, Paul Crist, and Stuart Lowry. Patrick introduced Resolution 22-005 expressing appreciation for outgoing board members, Bloom, Desselle, Crist, and Lowry.

Upon a motion duly made and seconded, the board adopted by acclamation Resolution 22-005 regarding appreciation of outgoing board members.

## 7. NERC Remarks

Jim Robb, President and CEO of NERC, addressed the MRO Board of Directors, outlining challenges on the horizon for industry and how the ERO Enterprise is working to address risk. He reflected on the pace of the energy transition and increasing extreme weather risks, which are having profound impacts on system planning and operation. Robb highlighted the following key risks identified in NERC's State of Reliability Report: 1) severe weather risks, 2) electric gas interdependencies, 3) continuing challenges with inverter based resource integration, and 4) cybersecurity threats and vulnerabilities.



He also introduced NERC's 2023 Work Plan Priorities that include tackling energy challenges posed by the changing resource mix and extreme weather, mitigating security risks, creating more agility in NERC's program areas, and investing in the enterprise's sustainability. Although addressing these challenges is a tremendous amount of work, Robb indicated NERC and the ERO Enterprise are up to the challenge.

## Stuart Lowry departed the meeting.

#### 8. HERO Award Recognition

Patrick next provided background for MRO's annual HERO Award, through which MRO recognizes a volunteer for exemplary initiative and commitment to advancing the concept and principles of HEROs throughout the MRO region and in support of MRO's vision and mission.

Tony Eddleman was announced as the recipient of the 2022 MRO HERO Award. Paul Crist, chair of the Organizational Group Oversight Committee, thanked Eddleman, noting that he was nominated for his initiative and commitment to advancing the HERO concepts and principles as an industry-wide leader on supply chain risks for the electric industry, in particularly through his efforts associated with the CIP-013 Supply Chain Risk Management Standard and Internal Controls.

Eddleman addressed the board and expressed gratitude to the board, staff, and his wife. He underscored the importance of making a plan and embracing controls when approaching compliance. He recalled inspiring work with the World Economic Forum, his address to the RSA conference to more than 26,000 attendees, and called upon his work as chair of the NERC Supply Chain Working Group (SCWG). He encouraged stakeholders to continue to partner with and trust the SCWG to develop tools and security guidelines enhance reliability and agility.

Patrick introduced Resolution 22-006 conveying the 2022 HERO Award to Eddleman.

Upon a motion duly made and seconded, the board unanimously approved Resolution 22-006 conveying the 2022 HERO Award to Tony Eddleman.

## 9. Finance and Audit Committee Report

Dr. Dana Born, Chair of the Finance and Audit Committee (FAC), thanked Thomas Graham for stepping in last quarter, and thanked the board for welcoming her colleague, Professor O'Sullivan.

Born advised that the IRS Form 990 had been filed, reminded board members of the audit that will be commenced by Baker Tilly in 2023, noted that FERC has approved MRO's 2023 business plan and budget, and advised the business plan and budget process for 2024 would begin in earnest in early 2023 as well.

Born referred the board to draft Resolution 22-004 regarding the renewal of a revolving line of credit, which she advised the FAC had unanimously recommended for board approval.

Upon a motion duly made and seconded, the board unanimously approved Resolution 22-004 authorizing renewal of line of credit.

## 10. Governance and Personnel Committee Report

Chair of the Governance and Personnel Committee (GPC), Jeanne Tisinger, shared that the GPC met on November 1, 2022, and had completed its annual review of MRO policies and procedures, and noted that proposed changes were approved earlier in the meeting via the consent agenda. She recognized recent initiatives related to employee retention, leadership development, and succession planning, adding that MRO's people are key to its resilience. She advised that there have been no reports to the compliance hotline, and confirmed that board attendance has been reviewed and no issues found. There were no questions.

## 11. Organizational Group Oversight Committee Report

Chair of the OGOC, Crist, reported that the OGOC conducted its annual joint meeting with the advisory council leadership the day prior on November 30, 2022. He reported that staff shared a presentation previewing the 2023 MRO Regional Risk Assessment. He noted the work of the breakout groups to discuss areas of focus and draft work plans. He noted a key takeaway was to seek additional opportunities for cross-council collaboration. The organizational groups will incorporate feedback from the discussion and seek OGOC approval of their updated work plans at the OGOC's first quarter meeting in 2023.

Crist called attention to the annual summary of accomplishments of the Compliance Monitoring and Enforcement Program Advisory Council (CMEPAC), Reliability Advisory Council (RAC), and Security Advisory Council (SAC) as provided within the agenda packet. He commended the councils for their contributions. There were no questions.

Tom Graham and Dehn Stevens departed the meeting.

## 12. Progress Made Following 2021 Cold Weather Event

Mark Tiemeier, Principal Technical Advisor, and Bryan Clark, Director of Reliability Analysis, addressed the board regarding progress to improve and expand cold weather preparedness activities since the Winter Storm Uri event in February 2021. Tiemeier and Clark explained that both the ERO Enterprise and MRO have undertaken significant outreach to help industry become more aware of and to mitigate future cold weather risk. They also shared information on both NERC and MRO's winter assessments, which outline that portions of MRO's region are at risk of insufficient energy supplies during the upcoming winter season. MRO's Regional Winter Assessment is anticipated for release on December 5 to be followed by a webinar on December 15 highlighting the assessment's findings.

Tiemeier and Clark responded to questions from board members regarding extrapolated impressions of the position of the region based on the onsite visits associated with MRO's new Generator Winterization Program, and whether an area of emerging focus may be the reliability of batteries when exposed to the same weather with similar vulnerabilities.

## 13. Written Reports

Chair Cox referred board members to the written reports on operations, outreach, and external affairs. There were no questions.
