CMEPAC Activities

Areas of Focus

- 1. Lessons learned and attendee feedback from 2022 Virtual CMEP Conference.
- 2. CMEPAC Monthly call currently has 146 registered for the calls. The August monthly call had 53 attendees and lasted for 27 minutes.
- 3. CMEPAC members will be assisting with the drafting of the MRO Regional Risk Assessment. Risk Assessment and Mitigation staff provided information on expectations for this upcoming project.
- 4. Setting expectations for the 2022 nomination process. The CMEPAC will have five open seats.

Accomplishments

Successfully hosted the 2022 Virtual CMEP Conference. The feedback received on the conference
was very positive. There were over 350 attendees between in-person and virtual. Those in
attendance included registered entities from across the ERO, not just MRO's footprint, as well as
staff from Northeast Power Coordinating Council (NPCC), ReliabilityFirst (RF), North American
Electric Reliability Corporation (NERC), and Federal Energy Regulatory Commission (FERC).

Challenges

1. The main challenge for the CMEPAC this year was providing webinars, due to CMEPAC member and MRO support staff resource constraints.

The Security Advisory Council (SAC) last met on June 22, 2022. All SAC meeting agendas and minutes are located here.

SAC Activities

Areas of Focus

- 1. Planning and preparing for the MRO Security Conference and Technical Training scheduled for October 4-5, 2022
- 2. Hosting webinars and soliciting webinar ideas from members and entities.
- 3. Conducting roundtables on high priority security topics.
- 4. Establishing connections with various agencies and inviting those agencies to provide briefings at SAC meetings.
- 5. The MRO Security Advisory Council Threat Forum (SACTF) will continue supporting the weekly Threat Call and establish approaches to enhance the exchange, discussion, and collaboration of threat information.

Accomplishments

- 1. The SAC hosted four webinars in 2022 in accordance with the work plan:
 - a. Integrating OT Security with Physical and Cybersecurity SOC's held on March 24, 2022
 - b. Ransomware Playbook Design held on March 29, 2022
 - c. Supply Chain Effectiveness Survey Results held on April 12, 2022
 - d. Information Sharing & Public/Private Partnerships held on April 26, 2022
- 2. The SAC contributed a newsletter article to the MRO newsletter, *Midwest Reliability Matters*:

 An Overview of Cyber Attack for Ransom (CAFR), by Michael Meason, Sr. Manager,
 Information and Security, Western Farmers Electric Cooperative, MRO SAC Vice Chair
- 3. The SACTF held 12 Threat Calls between June 1, 2022 and August 31, 2022. The Threat Call currently has about 276 approved registered individuals. The Threat Call lasts on average 19 minutes, and there is an average of 61 participants.
- 4. The SAC began working on the 2022 Annual Regional Security Risk Assessment (RSRA) and provided an initial report of top risks for inclusion in the annual RRA process. This work included surveys, threat briefings, and detailed breakout sessions with experts on physical, cyber, and operational risk in the MRO Region.

Challenges

- 1. Prioritizing the MRO SAC identified risks within the MRO SAC Work Plan for 2022
- 2. Maturing the work the SACTF is doing to include more than a weekly threat call
- 3. Attracting interested individuals to fill the 2 current, and eventually 4, vacant seats on the SACTF

For the OGOC's consideration, the following pages show a draft 2022 Q4 annual risk meeting agenda. This agenda incorporates feedback provided by the OGOC at their 2022 Q1 meeting following 2021's annual risk meeting. Changes to this year's agenda include:

- Shortened time for report-backs from breakout groups and reallocated that time to the staff presentation of the results of the Regional Risk Assessment to allow more time for OGOC questions and for staff to provide an overview of *all* risks, not just those that are high.
- Expanded the second breakout session and included prioritization of work plan items as a topic.

Risk Roundtables provide an opportunity for OGOC members, industry representatives from MRO Advisory Councils, and MRO staff to discuss risks to reliability and security of the bulk power system (BPS) in a trusted setting. A secondary goal of these discussions is to identify opportunities for MRO organizational groups to address these risks.

At the previous OGOC meeting, <u>Variable Transmission Line Ratings</u> was identified as the topic for this quarter's Risk Roundtable. The following provides an outline and proposed questions for the roundtable discussion.

1. Introduction

- a. Introduction of the risk and format of discussion (Richard Burt, Senior Vice President and Chief Operating Officer)
- b. Overview of variable transmission line ratings and FERC Order 881 Managing Transmission Line Ratings Mark Tiemeier, Principal Technical Advisor)

2. Risk Roundtable Discussion (Facilitator: OGOC Chair, Paul Crist)

- a. What are the benefits and challenges to power system reliability of variable transmission line ratings?
- b. What are the incremental benefits of Ambient Adjusted Ratings (AARs) over static ratings, and Dynamic Line Ratings (DLRs) over AARs?

- c. Is there a benefit to reliability in early implementation of AARs prior to the required date in FERC Order 881, and is there an opportunity to prioritize Facilities for early adoption?
- d. What challenges have companies had with implementing the different types of Variable Transmission Line Ratings, including Ambient Adjusted Ratings (AARs), Seasonal Ratings, and Dynamic Line Ratings (DLRs)?
- e. Are there any regional nuances of this risk for the MRO region?
- 3. Is there an action item for MRO staff or an organizational group?
- 4. Standing Question: What risk should we discuss at the next roundtable? For reference, the <u>high</u> <u>risks from the 2022 MRO Regional Risk Assessment</u> are the following:
 - a. Uncertainty of Winter Planning Reserve Margins
 - b. Generation Availability During Severe Cold Weather
 - c. Lack of Energy Assurance Assessments
 - d. Bulk Power System Modeling Accuracy
 - e. Supply Chain Compromise
 - f. Insider Threats
 - g. Malware/Ransomware

In 2019, MRO staff worked with the OGOC to develop a volunteer recognition program to acknowledge individuals for their dedication, commitment, and contributions to the success of MRO. Part of this program recognizes MRO organizational group members that retire from service for their dedication and commitment. The other part of the program includes an annual HERO Award that recognizes individuals that have shown exemplary initiative and commitment to advancing the concept and principles of Highly Effective Reliability Organizations (HEROs) throughout the MRO region and in support of MROs vision and mission over the past year. The program was implemented in 2020; more information can be found here.

MRO staff sent an announcement to MRO members and stakeholders soliciting nominations for the HERO Award. The nomination forms listing the candidates' qualifications are posted on <u>Boardvantage</u> for your review. Per the Volunteer Recognition Program, the MRO executive team, in consultation with the staff that support the organizational groups, reviews the HERO Award candidates and recommends three individuals to the OGOC for final selection at its third quarter meeting. I met first with the staff liaisons that support the organizational groups to discuss each candidate in detail. We reviewed the candidates' qualifications under the lens of the five HRO principles outlined in the Volunteer Recognition Program. I then obtained concurrence from the MRO executive team on our selections.

In closed session, the OGOC will select the recipient of the 2022 MRO HERO Award from the three finalists. The award recipient will be invited to the Annual Meeting of the MRO Members and Board of Directors on December 1, where he or she will be recognized by the OGOC Chair and executive staff, and will be provided a custom transmission tower award and plaque. That individual will have the opportunity to say a few words during the meeting.
